PARENT AND CARER CODE OF CONDUCT POLICY 2022-2023

Rationale

At Larkrise Primary School, we believe that staff, parents and children are entitled to a safe and protective environment in which to learn and work.

Therefore, behaviour that causes harassment, alarm or distress to users of the premises is contrary to the aims of the school.

Aims

That all members of the school community treat each other with respect at all times.

Expectations

- That adults set a good example to children at all times, showing them how to get along with all members of the school and the wider community
- That no members of staff, parents/carers or children are the victims of abusive behaviour or open to threats from other adults on the school premises
- Physical attacks and threatening behaviour, abusive or insulting language verbal or written, to staff, governors, parents and carers, children and other users of school premises will not be tolerated and will result in withdrawal of permission to be on school premises
- Any parent who is asked to leave the school premises will have the right to appeal to the school's Governing Body

Persons Causing Nuisance / Disturbance on School Premises:

Section 547 of The Education Act 1996

School premises are private property and parents have been granted permission from the school to be on the school premises. However, in the case of abuse or threats to staff, pupils or other parents, schools may ban parents from entering the school.

It is also an offence under section 547 of The Education Act 1996 for any person (including a parent/carer) to cause a nuisance or disturbance on school premises. The police may be called to assist in removing the person concerned.

Schools are not responsible for organising arrangements for children in the above circumstances. Parents/Carers will need to provide alternative arrangements for bringing children in to school.

Guidelines

Types of behaviour that are considered serious and unacceptable and will not be tolerated towards any member of the school community include the following:

- Shouting, either in person or over the telephone
- Inappropriate posting on social networking sites which could bring the school in to disrepute or be deemed as bullying
- Speaking in an aggressive/threatening tone

- Physically intimidating, e.g. Standing very close
- The use of aggressive hand gestures / exaggerated movements
- Physical threats
- Shaking or holding a fist towards another person
- Swearing
- Pushing
- Hitting e.g. slapping, punching or kicking
- Spitting
- Racist or sexist comments including sexual innuendo

Inappropriate use of social networking sites

Social media sites are being used increasingly to fuel campaigns and complaints against schools, headteachers, school staff and, in some cases, pupils and parents.

The Governing Body of Larkrise Primary School considers the use of social media sites in this way as entirely unacceptable and not in the interests of the children and the school community as a whole.

Any concerns an individual may have must be made through the proper channels by speaking to the class teacher in the first instance, then a Senior Leader, Headteacher and, ultimately, the Chair of Governors of the school. This will ensure that issues are dealt with fairly, appropriately and effectively for all concerned.

In the event that any individual is found to be posting libelous or defamatory comments on Facebook or other social media platforms, they will be reported to the appropriate 'report abuse' section of the network site. All social network sites have clear rules about the content that can be posted on the site and they provide robust mechanisms to report conduct or activity which breaches this. The school will also expect any individual to remove such comments immediately.

In the most serious cases, the school will also consider its legal options to deal with any such misuse of social networking and other sites. Additionally, and perhaps most importantly, is the issue of cyber bullying and the use by one child or a parent to publicly humiliate another by an inappropriate social network entry. We will take and deal with this as a serious incident of school bullying.

Thankfully, such incidents are extremely rare.

Unacceptable behaviour may result in the police being called.

The school reserves the right to take any necessary action to ensure that members of the school community are not subject to abuse, and this may include calling the police to remove the perpetrator of that abuse from the school site with immediate effect.

Parents/Carers do have the right to appeal by writing to The Chair of Governors within ten days of their permission to enter the school premises being withdrawn.

Responsibilities:

It is the responsibility of the Headteacher and Governors to monitor and annually review this Parental Behaviour Policy.

Procedure to address inappropriate behaviour by adults on the school site

At Larkrise Primary School we operate a 'zero tolerance' of the use of inappropriate behaviour anywhere on the school site.

(Inappropriate behaviour means disrespectful conduct towards people or property within the school site.)

Our Parental Behaviour Policy states:

- That all adults set a good example to children at all times, showing them how to get along with all members of the school and the wider community
- That no members of staff, parents/carers or children should ever be the victims of abusive behaviour or open to threats from other adults whilst on the school premises.

All staff and governors agree that any adult found to be using inappropriate behaviour towards other adults or children should be dealt with by using the following steps:

An adult approaches	The adult will be spoken to immediately and the issue		
another child	investigated by a Senior Leader. This will also be reported		
	to the Headteacher and recorded. The adult will receive a		
	warning letter.		
A parent/carer approaches	The parent/carer should report this to a member of staff or		
another parent/carer	a Senior Leader. The offending parent/carer/s will be		
	spoken to at the earliest opportunity after the incident and		
	reminded that we operate a zero tolerance policy towards		
	inappropriate behaviour. A warning letter will also be		
	issued to the parent/carer/s concerned. This will warn that		
	if the behaviour reoccurs, they could be banned from the		
	school site under section 547 of The Education Act 1996.		
A parent/carer approaches	This should be reported immediately to a Senior Leader.		
a member of staff	This will then be investigated as soon as practically		
	possible, and the member of staff will be kept informed of		
	the action taken. The parent/carer/s concerned will be		
	given a warning letter. This will warn that if the behaviour		
	reoccurs, they could be banned from the school site under		
	section		
	547 of The Education Act 1996.		
Recurring inappropriate	If a parent continues to use inappropriate behaviour, they		
behaviour	will be referred to The Policy for Parental Behaviour. This		
	indicates how anti-social behaviour, when not corrected,		
	can lead to an interview with the Headteacher and / or The		
	Chair of Governors which could then lead to a ban from

NB Depending on the circumstances of a particular incident, these procedural steps maybe amended at the discretion of The Governing Body.

The school reserves the right to move straight to a ban where the circumstances are deemed to be sufficiently serious.
